2. Declaration: European Regulation (EC) No 1907/2006 Registration, Evaluation Authorization and Restriction of Chemicals

Teledyne DALSA Digital Imaging (TDDI) produces products that would be considered an Article according to regulation Article 3(3): "an object which during production is given a special shape, surface or design which determines its function to a greater degree than its chemical composition".

As a manufacturer established outside of the European Economic Area (EEA) TDDI does not have direct obligations under the REACH Regulation however we understand that the businesses that import our products into the EEA may have such obligation.
